Sub: Temporary approval of affiliation of Indraprastha Law College, Cranter Neida, Uttar Pradesh for imparting five year BA. LLB law course.

Sir.

Legal Education Committee at its meeting held on 3rd May, 2014 considered the inspection report of the above mentioned college. After consideration, Committee made the following recommendations:-

The Legal Education Committee considered inspection report submitted by the inspection team. After consideration, the Committee is of the view that Indraprastha Law College, Greater Noida be granted fresh temporary approval of affiliation for running five year BA LL.B course with an intake of two sections of 60 students in each section for a period of two years i.e. for the academic years 2014-2015 and 2015-2016 subject to the following conditions:-

- College management should file extension of 1. affiliation of university after July, 2015.
- College should ensure the payment of salary to 2. teachers as per Rules 22 schedule III, Part IV of BCI Rules.
- The institution is directed to upgrade the library by 3. investing minimum Rs.50,000/- per year per

- Teacher Student ratio shall be as per Schedule-III, Rule-11, Clause-17, Part-IV of Bar Council of India Rules.
- Previous conditions imposed on the present Centre of Legal Education should properly be followed and fulfilled.
- 6. Institution should submit affidavit in compliance to the above conditions within three months.

So far request of two additional sections in LL.B three year course are concerned, it is not possible during intermagnum when once sections were allotted earlier and period is to end at 2014-2015. It is open for the college to raise this question when next inspection takes place.

The above recommendations were considered by the Bar Council of India at its meeting held on 9th May, 2014 and accepted the same.

College authorities are also required to apply to the Bar Council of India for further extension of approval of affiliation six months in advance before expiry of the period of approval of affiliation granted by the Bar Council of India i.e. on or before 31st December, 2015 failing which a late fee will be charged.
